Ella has advised the Province of Ontario on the financing of the Wataynikaneyap Project, involving the rollout of a 1,800 km transmission line to connect 16 remote First Nations communities in Northern Ontario, being the first majority Indigenous owned project to be developed in Canada, as well as numerous other projects in the energy sector. Ella is a member of the steering committee for Women in Energy Canada (WIECan).

Ella also has extensive experience advising on international project finance transactions. She acted in the largest private sector financing at the time in Romania (Mobifon S.A. – mobile GSM network.), the financing of the development of an oil and gas project in India by an international financial institution, and the financing by other international financial institutions of the development of an oil terminal in Georgia, a mine development in Turkey, multiple mobile GSM projects in Eastern and Central Europe, a major eucalyptus pulp mill in Uruguay and numerous other project finance transactions in emerging markets globally.

Prior to returning to Infrastructure Ontario in 2019, Michael served as Special Advisor to the Government of Ontario on the upload of the Toronto subway system.

Michael also previously served as Head of Strategic Partnerships & Government for the Investment Management Corporation of Ontario ("IMCO").

As the Global Director of Infrastructure Planning & Advisory at Hatch, Michael helped governments create public private partnerships ("P3s"), and helped private investors effectively negotiate the terms and scope of those partnerships.

From 2014 to 2016, Michael was Senior Vice President of Commercial Projects at Infrastructure Ontario. In that role, he was responsible for commercial transactions related to the financing, development, and divestiture of public assets in Ontario (e.g. land, buildings, services). His team structured P3s related to energy, transit and social infrastructure, and contracted private entities to deliver services through a range of outsourced models.

Prior to this, Michael was an Associate Principal with McKinsey & Company, where he was a core leader of the Canadian Public Sector Practice. He helped provincial and federal ministries reduce costs, improve service, and analyze the effectiveness of money spent on economic development and innovation.

Joey Comeau is Chief Operating Officer and Executive Vice President, Capital Services, at EllisDon, a construction and services company with 3,000 employees and \$5 billion in annual construction revenues. EllisDon Capital is the developer and equity arm for EllisDon on AFP/ P3 infrastructure and real estate projects. Since 2004, EllisDon has been successful in

reaching Financial Close on 53 infrastructure projects with a combined capital value of over \$23 billion. The projects range in assets classes such as healthcare, transit, justice, education, and accommodation. In real estate development, EllisDon has begun directly investing in residential projects and mixed-use projects across the GTA and has two condominium and two affordable housing developments underway.

Joey joined EllisDon in 2014 and has been directly involved in leading both the infrastructure and real estate development and investing strategies for EllisDon over that period of time.
